Regular Meeting Minutes for Thursday, April 25, 2019

A Regular Session of the Piedmont Recreation Commission was held April 25, 2019, in the City Hall Council Chambers at 120 Vista Avenue. In accordance with Government Code Section 54954.2(a) the agenda for this meeting was posted for public inspection on April 22, 2019.

Chair's Report Chair Roland had no report.

Director's Report Recreation Director Sara Lillevand reported that today was Michael Murphy's

last day with the Recreation Department after 37 years. A nice luncheon was held and a community-wide celebration will be held on May 5th at Hampton Park from 1:00 to 3:00 p.m. Chair Roland and Commissioners recognized the

dedicated service of Michael Murphy and wished him well.

Ms. Lillevand referred to previous requests by Commissioners for specific agenda topics. She confirmed these items have not been forgotten and will be

agendized in upcoming meetings.

Skateboard and Scooter Subcommittee

Commissioner Burge reported that the subcommittee and John Wilk reviewed options for expanding and improving skating and scooter opportunities. They will present their final report at the next meeting on May 15th. He briefly reviewed the subcommittee's general findings and stated feedback could still be provided via the on-line survey.

Ms. Lillevand spoke about the proposed skate spot and voiced appreciation of the subcommittee's creativity in serving skaters.

There was no **Public Testimony** received.

Pickleball Trial

Ms. Lillevand announced the launch of the 8-month Pickleball trial. Pickleball began on April 6th. Pickleball play is allowed on Tuesday and Thursday mornings and Sunday afternoons at Beach; and on Wednesdays and Fridays early afternoons at Hampton. Four courts were striped on the tennis courts at Beach and 4 courts at Hampton with different configurations. The immediate neighbors of Beach and Hampton tennis courts will be surveyed beginning in May to determine any noise impacts.

Separately, the Department is offering a recreation program on Saturday mornings at the Piedmont Middle School PE courts.

Commissioners briefly discussed participation levels, court usage on Saturday mornings and on the tennis courts, and relayed concerns regarding the light color of the striping, which Ms. Lillevand confirmed would be re-painted if pickleball continues long-term at Hampton.

There was no **Public Testimony** received.

Chair Roland asked for future updates by staff regarding the Pickleball courts behind the middle school.

New Recreation Supervisor

Ms. Lillevand introduced and welcomed Jackson Stearns, the City's new Recreation Supervisor. She described Mr. Stearns experience and background, and Commissioners welcomed him to the City. Mr. Stearns said he looks forward to serving the Piedmont community.

There was no **Public Testimony** received.

Piedmont Community Pool Closures, Repairs & Staffing

Ms. Lillevand reported the pool was partially closed during the School District's spring break due to its proximity and conditions associated with demolition of the Alan Harvey Theatre on the high school campus. The pool remained open in the early mornings and evenings for lap swimming and for swim team practices but closed during construction hours, and PRD was not able to run a Lifeguard Training class.

Ms. Lillevand described needed pool repair projects, stating she will return with a more thorough report to present to the City Council later this year.

Ms. Lillevand indicated that interviews will be held tomorrow for the vacant Aquatics Coordinator position. She also indicated that alternative methods of lifeguard training are being reviewed in an effort to speed the training process. She suggested that those interested in a lifeguard position can contact staff or apply on-line.

There was no Public Testimony received.

2018 Betty C. Howard Award

Ms. Lillevand provided background about the Betty C, Howard Award, as well as the selection criteria and process. She indicated that there are two categories for the award, one for employees and another for volunteers. For the employee award, she recommended preschool teacher Joanna Wood, describing her many qualifications. For the volunteer category, she recommended volleyball coach Zach Jones, describing his contributions to the city.

There was no **Public Testimony** received.

Commissioners voiced their support for Ms. Wood and Mr. Jones and thanked staff for continued recognition of individuals in the award program.

Piedmont Recreation Commission Skate and Scooter Sub-Committee Report

5/15/2019

Sub-Committee Members - Vincent Fischer, Carrie Graham Lee, Glyn Burge, and John Wilk (PRD Liaison)

<u>Purpose</u>

Review current skating and scootering options in the City of Piedmont including the Piedmont Skate Park and explore ways to expand and improve opportunities.

The Recreation Commission has received numerous comments from the public about the poor functionality and deteriorating condition of the Kennelly skate park as well as the lack of skate friendly areas in the city. In addition, the recently approved Beach Field Master Plan excluded any skate friendly features from its design.

The committee elected to focus on the following two issues:

- 1. Kennelly Skate Park usage and functionality
- 2. Alternate locations in Piedmont for an additional skate area

Kennelly Skate Park



Committee members met on several occasions at the Kennelly Skate Park and also visited several other skate parks in Oakland, Alameda and Berkeley. The committee reviewed a 2016 evaluation of the Kennelly Skate Park completed by Sean O'Loughlin, Skatepark Coordinator for the City of Berkeley.

The committee solicited feedback from the community via an online user survey and received 42 responses.

Survey observations:

- 1. The majority of park users are 18 or younger and are from Piedmont.
- 2. The majority of users are beginner or intermediate skill level.
- 3. The majority of users do not feel a park monitor is helpful and would like park hours to be expanded.
- 4. The majority of users feel the park is too difficult and that easier features and a better flow throughout the park would be helpful.
- 5. The majority of users do not feel parking is a problem.

Committee observations:

- 1. Access is difficult and limited and irregular hours of operation frustrate users. Some park users end up climbing the fence.
- 2. The park design is not functional for beginner and intermediate skaters who are the majority of users. Many features are simply too difficult to use. And the flow from one feature to another is poorly laid out and create congestion. For example, the bowl at the bottom is a very difficult feature that is rarely used and is located where errant boards can run into it creating a dangerous situation.
- 3. There is no water fountain.
- 4. Park concrete is cracking in many areas creating safety concerns.
- 5. The current access through Coaches Field requires users to walk up to the parking lot and back across the field to the park access gate. As many skate park users walk to the park from Piedmont, having a direct sidewalk connection below the baseball backstop on Moraga would greatly improve access.
- 6. There is no shade or spectator area or picnic tables. Families and groups can't really use the park for events and lack of a meeting area makes programming (such as summer camps) difficult. The park has a spectacular view of the bay which is not currently taken advantage of.
- 7. Due to the lack of gathering space and infrastructure and difficult nature of the features, programming and rentals are virtually non-existent. For several years the Cal Skate Camp rented the park for summer camps. Cal no longer uses the park and indicated part of the reason is that it is simply too difficult for beginners.

Recommendations

- 1. Redesign the park to make it more attractive to beginner and intermediate skaters.
- 2. Add a meeting or spectator area to facilitate group use with shade.
- 3. Consider opening the park without a monitor.
- 4. Add pedestrian access off of Moraga below the baseball diamond.


5. Add a water fountain.

Alternate Skate Area Locations in Piedmont

The committee discussed whether it would be practical to locate another area in town for a skate park. Many residents have concerns about noise, property damage, and the potential nuisance factor and, as a result, the committee felt this would be a daunting task beyond its capabilities.

As a potential alternative to a full sized skate park, the committee came up with the idea of a skate spot. A skate spot would be a micro skate park with perhaps 2-3 skate friendly features (such as a rail, a short ramp, or a box) that can fit into a small area. Similar parks have been built in Oakland and Berkeley with success. All are different sizes and have different features. The unifying theme is that they give skaters a thoughtful well designed area for skateboarding that is not disruptive to neighbors.

One possible location for a skate spot in Piedmont is next to the Piedmont Recreation Department offices at 358 Hillside. The PRD building has a long driveway on its west and south sides that is rarely used for vehicles and, according to Director Lillevand, is not a required maintenance or fire access road. Also importantly this location is screened from residences by the PRD building itself and is well located for use by youth ages 12-18 due to its proximity to PHS and PMS. A photo of the proposed skate spot location is below.



The committee believes that building a skate spot next to PRD would be relatively inexpensive. Features might include a slide rail, a box, and perhaps a small ramp. The asphalt roadway would likely need to be leveled and smoothed out. And possible a few benches and signage added.

The committee recommends that a design and budget be developed for the skate spot at PRD. If the PRD skate spot is successful, the features and concept could be applied to other areas in town where appropriate.
